

Terms & Conditions March 2018

Information on how to enter and prizes form part of these conditions. By participating, entrants agree to be bound by these conditions. Entries must comply with these conditions to be valid.

Eligible Entrants

Entry is open to residents of Australia over the age of 18 who have children (or are guardians of children) aged 3-13. Employees and their immediate families of the Promoter, its related entities and any agencies associated with this competition are ineligible to enter.

Entry Period

Judging Dates

Judging will take place from 20 April 2018 to 4 May 2018. All entries will be judged individually on their merits based on their creative answer.

The judging panel will then select one overall 2018 Woolworths Aspiring Athletes National Winner from the State/Territory winners.

Prize Details

Prize consists of:

State/Territory Prize:

National Prize:

Prize Delivery

The collection of the National Prize is the responsibility of the winner and it will expire after a year.

Each prize will be delivered to a location to be advised by the Promoter. The Promoter will arrange a date and time suitable for the collection of the prize and advise the winner of the location that the prize must be collected from.

Notification of Winners

Winners will be notified by the telephone number provided on the entry 'Nomination Form' by 18 May 2018.

FURTHER DETAILS

(c) all photographs are subject to the approval of the Promoter. The Promoter reserves the right to vet all entries at any time and reserves the right to request the removal of any entries from any Platform or such websites at any time in its absolute discretion.
