

## **Woolworths Win A Day Of Pampering Competition Terms and Conditions**

- 1. Information on how to enter (available at <a href="https://www.woolworths.com.au/shop/page/pamper">https://www.woolworths.com.au/shop/page/pamper</a>) the Promotion and a description of the prizes that may be won in the Promotion form part of these Terms & Conditions of Entry. Participation in the Promotion constitutes acceptance of these Terms & Conditions of Entry. Entries not complying with these Terms & Conditions of Entry are ineligible and the Promoter reserves its absolute right to disqualify any entries do not comply with these Terms & Conditions of Entry.
- The Promotion is open to all Australian residents, however participants under the age
  of 18 must obtain the prior permission of a parent or legal guardian over the age of 18
  to enter.
- 3. Entry into the Promotion is free. Directors, management and employees of Woolworths Limited and its agencies directly associated with this Promotion are ineligible to enter.
- 4. Promotional period commences Wednesday 4th May 2016 at 00:01am AEST and concludes Tuesday 17<sup>th</sup> May 2016 at 11:59pm AEST.
- 5. To enter participants must during the Promotion Period:
  - a. Log on to woolworths.com.au,
  - Spend \$150 or more on products online (after any applicable discounts and excluding smoking/tobacco products and/or accessories, flowers, liquor, Delivery Saver products and, delivery costs) in a single transaction,
  - c. Enter the promotional code LUXURY at the online checkout for that transaction and.
  - d. Complete that transaction between Wednesday 4th May 2016 at 00:01am AEST and Tuesday 17<sup>th</sup> May 2016 at 11:59pm AEST.
